

AFS Licensee Registration

This Australian Finance Services (AFS) Licensee Registration documents the agreement between Mercer Super Trust (Mercer Super) and the AFS Licensee in relation to:

- Payment of advice fees to the AFS Licensee, including that Mercer Super is permitted to issue recipient created tax invoices (RCTI's) to the AFS Licensee.
- The circumstances in which Mercer Super will pay an advice fee in respect of advice provided by the AFS Licensee's Authorised Representatives.
- 3. The requirement to provide evidence of advice being provided to member that meets the sole-purpose test.

Step 2: Review and Monitoring of Advice Fee Consent

To ensure Mercer Super can continue to meet its obligations under the SIS Act, Mercer Super is required to monitor advice fee payments from Mercer Super member accounts. Mercer Super will periodically review Advice Fee Deduction requests and payment of Advice Fees to ensure that they meet the requirements set out in Advice Fee Deduction form.

- Mercer Super may request information and/or advice documents from the AFS Licensee or its Authorised Representatives from time to time to ensure Mercer Super can continue to meet its Trustee oversight obligations. Mercer Super will keep the documents confidential and will hold them in accordance with the Privacy Act 1988 (Cth) (including the Australian Privacy Principles).
- The AFS Licensee agrees that Mercer Super Advice Fee Deduction form is not a substitute for, and must not be used to satisfy, any consent or disclosure obligation imposed on the AFS Licensee or its Authorised Representatives under the Corporations Act 2001 (Cth) (including the rules relating to the charging of ongoing advice under Part 7.7A Corporations Act).
- The AFS Licensee agrees that Mercer Super can request the aforementioned information from either the Authorised Representative or from the AFS Licensee.

Step 3: Recipient Created Tax Invoice (RCTI) for Mercer Superannuation (Australia) Limited

Recipient Created Tax Invoice Agreement for Mercer Superannuation (Australia) Limited

This Agreement will enable Mercer Superannuation (Australia) Limited to prepare Recipient Created Tax Invoices ("RCTI's"). Please read it carefully and complete the details below. This agreement should be then returned to Mercer Superannuation (Australia) Limited.

This agreement is made between the Recipient and the Supplier on the date specified below:

- 1. The Recipient acknowledges and agrees that it:
 - a. can issue tax invoices in respect of the supplies;
 - b. is registered for GST and that it will notify the supplier if it ceases to be registered or if it ceases to satisfy any of the requirements for the issuance of a RCTI; and
 - c. indemnifies the supplier for any liability for GST and penalty that may arise from an understatement of the GST payable as a result of an error by the recipient on any supply of which it issues a RCTI.
- 2. The Supplier acknowledges and agrees that:
 - a. it will not issue tax invoices in respect of the supplies;
 - b. it is registered for GST and that it will notify the recipient if it ceases to be registered;
 - c. the ABN specified below is true and correct; and
 - d. it will be bound by these terms and conditions.

Step 4: AFS Licensee Declaration

The Supplier acknowledges that the Recipient can issue tax invoices in respect to the provision of advice services provided by financial advisers listed on ASIC's financial adviser register in respect of the Supplier as an AFS Licensee.

The Supplier acknowledges that it is registered for the goods and services tax ('GST') at time of submitting this AFS Licensee Agreement, and agrees to notify the Recipient if it ceases to be registered for GST.

The Recipient acknowledges that it is registered for GST and agrees to notify the Supplier if it ceases to be registered for GST. Both the Recipient and Supplier agree that they are parties to this RCTI agreement.

The Recipient and Supplier agree that the terms of this RCTI agreement are automatically modified in accordance with current GST law and Tax Rulings as required for the issuance of a RCTI from time to time.

Bank account details can only be updated by the submission of a signed updated AFS Licensee Registration form. Requests payment having complied with any terms separately agreed between the Recipient and the Authorised Representative.

The AFS Licensee agrees it is the AFS Licensee's responsibility to ensure that members of the Mercer Super Trust who participate in Mercer Super Trust's advice fee offering receive the financial advice that is paid to the Licensee in respect of those members.

The AFS Licensee agrees to the terms set out in this AFS Licensee Registration.

The AFS Licensee declares that it understands Mercer Super's advice fee payment conditions and sole purpose test obligations.

The AFS Licensee agrees that the payment of advice fees from a member's account is at the discretion of the Recipient.
