

# Government benefits for seniors



#### After decades of hard work, it's time to make the most of governmentfunded benefits.

When you're planning for retirement, it's important to know what benefits are available to supplement your income or provide concessions and discounts that could help your money go further. Apart from the government <u>Age Pension</u>, there are other commonwealth and state-based benefits that can support your journey through retirement.

## **Commonwealth Seniors Health Card (CSHC)**

The Commonwealth Seniors Health Card allows you to access cheaper rates on certain Medicare services and prescription items. It provides:

- · cheaper medication
- bulk billed doctor visits
- · a refund for medical costs once you hit the Medicare Safety Net

Depending on which state you live in, you may also get access to discounts on energy bills, property and water rates, other health care costs and public transport fares. You can find more information on the concessions available by state in the table on page 2.

To qualify for the card you must:

- have reached age 67
- be an Australian citizen, a holder of a permanent visa, or a Special Category Visa holder and have been in Australia for two years
- · reside in Australia
- not be receiving a social security pension or benefit, a Department of Veterans' Affairs service pension
- meet the requirements of an annual income test

Apply for a Commonwealth Seniors Health Card through **Services Australia** (Centrelink).

### **Pensioner Concession Card**

If you already receive <u>income support payments</u> from Services Australia you may be eligible for a Pensioner Concession Card which provides access to cheaper medicine, bulk-billed doctor visits, help with hearing services and discounts to redirect your mail. If you're eligible, you'll receive the card from Services Australia – no need to apply.

#### **Seniors Cards**

These vary by state or territory, but as a general rule, if you're aged 60 or over and work less than 20 hours per week, you may be eligible for a Seniors Card which offers discounts on public transport and some goods and services.
